WHEREAS, upon review of Precinct #11 located at Alcott Elementary, 460 West Kennett Road Pontiac, Michigan 48340 and within the guidelines of Michigan Election Law Section 1.68.659 consolidation of election precincts, It is with high recommendation that we make a permanent move of this 1 precinct known as precinct #11 to Kennedy Junior High School 1700 Baldwin Avenue Pontiac, Michigan 48340.

WHEREAS, the recommended changes would have Precinct #11 located in the gymnasium of Kennedy Junior High School.
