HDC-14-22 – 522 WEST IROQUOIS – SEMINOLE HILLS HISTORIC DISTRICT WINDOW REPLACEMENTS

Applicant is seeking to replace (31) thirty-one windows in the home with a vinyl replacement. The home is a contributing structure built in 1929. Commissioner Henk asked the applicant why he wanted to use vinyl replacement windows instead of wood. The applicant said cost was the overriding reason.

RECOMMENDATION:

To deny the proposed certificate of appropriateness (HDC-14-22) for vinyl replacement windows, as the proposed alterations do not meet the Secretary of the Interior Standards for Rehabilitation, specifically standard (6) six.

HDC-14-21 – 169 CHIPPEWA – SEMINOLE HILLS HISTORIC DISTRICT ROOF REPLACEMENT / WINDOW REPLACEMENT APPLICANT – THD AT HOME SERVICES Property Owner - Samuel Andrews

Applicant is seeking to replace the roof of the home with Tamko Heritage Shingles in the color of Virginia Slate; also seeking approval to replace the window with a vinyl replacement window, (nine over nine) grid pattern.

RECOMMENDATION:

To deny the proposed certificate of appropriateness (HDC-14-21) for vinyl replacement windows, as the proposed alterations do not meet the Secretary of the Interior Standards for Rehabilitation, specifically standard (6) six.

THE HOME BUILT IN 1951, IS NOT A CONTRIBUTING STRUCTURE. VINYL WINDOWS WOULD NOT DETRACT FROM THE CHARACTER OF THE HOUSE BUT THE PROPOSED (NINE OVER NINE) GRID PATTERN DOES NOT EXIST AT THE SITE AND MAY CREATE A FALSE SENSE OF HISTORICAL DEVELOPMENT.

COMMISSIONER HENK MOTIONED TO APPROVE REPLACEMENT OF EXISTING ROOF WITH TAMKO HERITAGE SHINGLES IN THE COLOR OF VIRGINIA SLATE AND REPLACEMENT OF EXISTING WINDOW WITH A VINYL WINDOW BECAUSE THE HOME IS A NON-CONTRIBUTING STRUCTURE. COMMISSIONER PORTER SUPPORTED.

CHAIRMAN DAVID ASKED IF THERE WAS ANY UPDATE ON CERTIFIED LOCAL GOVERNMENT STATUS. COMMISSIONER JAMES SAID THE PLAN WAS TO REVIEW ONE OF THE (5) REQUIREMENTS AT EACH MEETING. COPIES OF THE CERTIFIED LOCAL GOVERNMENT REQUIRMENTS WERE DISTRIBUTED.

COMMISSIONER HENK SAID THERE WAS NO UPDATE FOR ELIMINATION OF THE BOND.
